








**Bruce Hedin, Ph.D.**

At H5, where, until its recent acquisition, he served as Principal Scientist, his responsibilities included the design and oversight of sampling and measurement protocols to validate the results of AI-enabled review technologies (such as TAR). Dr. Hedin also supports counsel engaged in meet-and-confer discussions regarding the use of TAR.

Dr. Hedin is a frequent writer and speaker on the role of sampling and measurement in applying AI-enabled technologies to legal challenges. He has also contributed to initiatives, at US NIST, at the IEEE, and at the WEF's Centre for the Fourth Industrial Revolution, that seek to ensure that, to the extent AI is adopted in the service of the law, it is done so on the basis of an informed trust.
